Nomination of experts for participation in in-depth reviews

Note by the secretariat

1. By its decision 9/CP.2, the Conference of the Parties (COP), at its second session, decided that the review process of national communications from Annex I Parties should be continued in accordance with the relevant decisions of the Conference of the Parties.
2. The secretariat has received a number of nominations from governments with the names of experts recommended for participation in in-depth reviews (see annex I below). Many of these experts took part in reviews of first national communications from Annex I Parties (see FCCC/SBI/1997/20). At present, the secretariat is preparing for the review of second national communications from Annex I Parties, and therefore it seems advisable to update the list of nominations since some of them were submitted as early as in 1994.
