Supervisory body for the mechanism under Article 6, paragraph 4, of the Paris Agreement		
<i>Article 6, paragraph 4, of the Paris Agreement states that a body shall be designated by the CMA to supervise the mechanism established to contribute to the mitigation of greenhouse gas emissions and support sustainable development. Should agreement be reached at CMA 2 to designate this body, as well as its composition and launch, the relevant regional groups and constituencies will be invited to submit nominations for the elections to be held at the closure of CMA 2.</i>
