Objectives

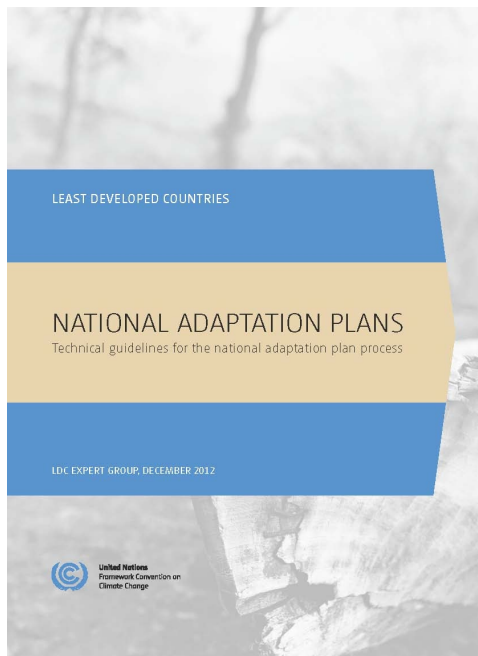
National Adaptation Plans

- **Main international vehicle for implementing adaptation nationally**, integrating subnational and local actions, and linking to regional and global processes.
- Decision 1/CP.16 established the process to **enable** the LDCs and other **developing country Parties** to formulate and implement NAPs, to identify **medium- and long-term adaptation needs** and **develop and implement strategies and programmes to address those needs**.
- Objectives of the NAP (decision 5/CP.17):
 - **Reduce vulnerability** to climate change, by **building adaptive capacity and resilience**;
 - **Facilitate the integration of climate change adaptation**, into relevant new and existing policies, programmes and activities, esp. development planning processes/strategies, within all relevant sectors and at different levels, as appropriate.



National Adaptation Plans

- NAPs are submitted to the UNFCCC and shared via **NAP Central** (<http://napcentral.org>)
- To date, 45 countries have submitted their NAP;
- Need for accelerated progress on both the formulation and the implementation of NAPs



UN4NAPs

- A UN-wide **rapid technical backstopping initiative for National Adaptation Plans (NAPs)**, launched in 2021 by the UNFCCC secretariat, **in response to mandates for engaging international organizations in support of climate change adaptation.**
- It offers a **platform for countries to communicate their needs for technical assistance** on an ongoing basis.
- The partnership enables the **UN-wide system of organizations** and other intergovernmental organizations to **respond to technical requests** identified by any country that is in the process of formulating or implementing its NAP.
- Upon receipt of requests for technical assistance, the UNFCCC secretariat immediately communicates with relevant partners from a roster of more than 45 UN and intergovernmental organizations for a prompt response.

Categories of technical assistance:



Simple technical queries which can be answered by relevant agencies via email;



Delivery of specific data/knowledge products (such as datasets, analytical tools, guidance material);



Longer-term capacity development/engagement with the requesting country;



Review of draft NAPs upon request by a country, based on agencies' area of expertise, with a view to enhance the coverage of issues to facilitate subsequent implementation.

Technical assistance available through UN4NAPs relevant to NAP implementation

- Applying best available science in practice of assessment, planning and implementation of adaptation;
- Development of national knowledge and information systems to support adaptation planning, implementation and reporting;
- Use and application of frontier technologies to advance adaptation assessment, planning and implementation;
- Research and systematic observations in support of adaptation assessment, planning and implementation;
- Design of implementation strategies for adaptation using a mix of climate and risk financing.



Examples for the types of requests submitted to UN4NAPs

Requests for technical assistance that have been submitted by countries include:

- Technical assistance to strengthen efforts of accessing climate finance;
- Identifying business cases and bankable projects for different sectors, based on the NAP;
- Reviewing different national policies and adaptation strategies;
- Strengthening capacities in climate observation and modeling and access to climate scenarios;
- Improving knowledge in biodiversity assessments and conservation measures for biodiversity, water and soil;
- Strengthening resilience of livestock and crops;
- Developing nature-based solution strategies;
- Strengthening monitoring and evaluation as well as information management systems.



How to submit requests for technical assistance

Country representatives are invited to, in coordination with their UNFCCC national focal point, submit any technical queries or requests for technical assistance in relation to NAP formulation or implementation, on an ongoing basis, to **un4naps@unfccc.int**

The queries and requests will be disseminated to those organizations that are relevant to the thematic area in question for prompt response.
