

- 2. Background: In accordance with rule 10 of the draft rules of procedure being applied, the secretariat, in agreement with the President of CMA 6, Mukhtar Babayev (Azerbaijan), drafted the provisional agenda for CMA 7 after consultations with the Bureau of the governing bodies and taking into account the views of Parties.
- 3. Action: The CMA will be invited to adopt its agenda.

#### (b) Election of additional officers

- 4. *Background*: If any member of the Bureau represents a State that is not a Party to the Paris Agreement, consultations will be required to identify a nominee representing a Party to the Paris Agreement to replace such a member in accordance with Article 16, paragraph 3, of the Paris Agreement. Parties are invited to recall decision <u>3/CP.23</u> and actively consider nominating women.
- 5. Action: The CMA will be invited, as necessary, to elect additional members of the Bureau.

### 4. Matters relating to the global stocktake

- (a) Procedural and logistical elements of the overall global stocktake process
  - 17. *Background*: CMA 5 welcomed the conclusion of the first global stocktake and, recalling paragraph 15 of decision 19/CMA.1, decided that consideration of refining the procedural and logistical elements of the overall global stocktake process on the basis of experience from the first global stocktake shall commence at SB 60 and conclude at CMA 6.<sup>14</sup> Matters relating to this agenda sub-item are considered under the SBSTA and the SBI.<sup>15</sup>
  - 18. CMA 6 requested SB 62 to continue consideration of this matter with a view to recommending a draft decision for consideration and adoption at CMA 7. <sup>16</sup> SB 62 agreed that SB 63 will continue consideration of this matter with a view to CMA 7 concluding consideration thereof. <sup>17</sup>
  - 19. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI.

- (b) Reports for 2024 and 2025 on the annual global stocktake dialogue referred to in paragraph 187 of decision 1/CMA.5
  - 20. *Background*: CMA 5 requested the Chairs of the subsidiary bodies to organize an annual global stocktake dialogue, starting at SB 60, and requested the secretariat to prepare a report for consideration at CMA 6.18
  - 21. CMA 6 considered the summary report on the first annual global stocktake dialogue but could not conclude consideration thereof. In accordance with rules 10(c) and 16 of the draft rules of procedure being applied, this item has been included in the provisional agenda for this session.<sup>19</sup>
  - 22. Action: The CMA will be invited to take any action it deems appropriate. The CMA will also be invited to consider the 2025 summary report on the annual global stocktake dialogue.

#### 5. United Arab Emirates just transition work programme

- 23. *Background*: CMA 4 established a work programme on just transition for discussion of pathways to achieving the goals of the Paris Agreement outlined in Article 2, paragraph 1, in the context of Article 2, paragraph 2.<sup>20</sup>
- 24. CMA 5 decided on the work programme elements and that implementation thereof shall start immediately after that session under the guidance of the SBSTA and the SBI through a joint contact group to be convened at each of their sessions, starting at SB 60, with a view to the subsidiary bodies recommending a draft decision for consideration and adoption by the CMA at each of its sessions.<sup>21</sup> Accordingly, matters relating to this agenda item are considered under the SBSTA and the SBI.<sup>22</sup>
- 25. CMA 5 requested the Chairs of the subsidiary bodies to prepare an annual summary report on the dialogues held as part of the work programme.<sup>23</sup>
- 26. CMA 6 requested SB 62 to continue consideration of this matter with a view to recommending a draft decision for consideration and adoption at CMA 7.<sup>24</sup>
- 27. SB 62 agreed that SB 63 will continue consideration of matters relating to the implementation of the United Arab Emirates just transition work programme, taking note of the informal note prepared at SB 62,<sup>25</sup> with a view to recommending a draft decision thereon for consideration and adoption at CMA 7.<sup>26</sup>
- 28. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI.

# 6. Sharm el-Sheikh mitigation ambition and implementation work programme

- 29. *Background*: CMA 3 established a work programme for urgently scaling up mitigation ambition and implementation in this critical decade.<sup>27</sup>
- 30. CMA 4 requested the secretariat to prepare, under the guidance of the co-chairs of the work programme, a report on each of the dialogues held under the work programme, and an annual report comprising a compilation of the individual dialogue reports for consideration by the CMA, the SBSTA and the SBI. CMA 4 also requested the SBSTA and the SBI to consider progress in implementing the work programme with a view to recommending a draft decision for consideration and adoption by the CMA at each of its sessions.<sup>28</sup> Accordingly, matters relating to this agenda item are considered under the SBSTA and the SBI.<sup>29</sup>
- 31. *Action*: The CMA will be invited to consider the draft decision recommended by the SBSTA and the SBI and the annual report prepared by the secretariat, under the guidance of the co-chairs of the work programme, and to take any action it deems appropriate.

# 7. Reporting and review pursuant to Article 13 of the Paris Agreement: provision of financial and technical support to developing country Parties for reporting and capacity-building

- 32. Background: CMA 3 decided that this matter will be considered at CMA 4 and at each session thereafter, including consideration of the support provided to developing country Parties for reporting and related capacity-building under Article 13 of the Paris Agreement.<sup>30</sup> CMA 5 requested the secretariat to undertake activities related to this matter in 2025,<sup>31</sup> including preparing a synthesis report<sup>32</sup> and organizing a facilitative dialogue, which took place on 18 June 2025 during SBI 62. CMA 6 requested the secretariat to hold a workshop, which also took place on 18 June 2025 during SBI 62, and prepare a workshop report.<sup>33</sup>
- 33. SBI 62 invited Parties to submit reflections on the activities mandated in decisions 18/CMA.5 and 21/CMA.6, and requested the secretariat to organize a workshop, in world café format, to be held at SBI 63, for Parties to reflect on those mandated activities and take into account views contained in the submissions with a view to considering future activities under the relevant SBI agenda item, including a dialogue with the GEF and its implementing agencies. SBI 62 agreed that SBI 63 will continue consideration of these matters with a view to recommending a draft decision thereon for consideration and adoption at CMA 7.34
- 34. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBI.

## 8. Matters relating to adaptation

#### (a) Global goal on adaptation

- 35. *Background*: CMA 5 requested SB 60 to initiate consideration of matters relating to the global goal on adaptation with a view to providing recommendations for consideration and adoption at CMA 7 at the latest.<sup>35</sup>
- 36. CMA 6 requested the Chairs of the subsidiary bodies to invite the technical experts referred to in paragraph 1 of decision <u>3/CMA.6</u> to further refine the indicators and produce a consolidated list of indicator options for Parties and a progress report.<sup>36</sup> SB 62 agreed that the work of the experts would continue immediately after the closure of those sessions with

a view to the experts reducing and refining the indicators on the basis of guidance on criteria for the indicators and taking into account additional guidance provided at the sessions.<sup>37</sup> CMA 6 confirmed<sup>38</sup> that CMA 7 will decide on the final list of indicators.

- 37. CMA 6 launched the Baku Adaptation Road Map with the aim of advancing progress in line with Article 7, paragraph 1, of the Paris Agreement and supporting the implementation of the elements outlined in paragraph 38 of decision <u>2/CMA.5</u> and requested the subsidiary bodies to develop modalities for work under the Road Map.<sup>39</sup>
- 38. CMA 6 established the Baku high-level dialogue on adaptation, to be convened on the margins of each CMA session by the President of that session and the President of the previous session with the aim of identifying ways of enhancing the implementation of the United Arab Emirates Framework for Global Climate Resilience. <sup>40</sup> The first high-level dialogue on adaptation will take place on the margins of this session.
- 39. SB 62 agreed that SB 63 will continue consideration of matters relating to the global goal on adaptation with a view to recommending a draft decision for consideration and adoption at CMA 7.<sup>41</sup> Accordingly, matters relating to this agenda sub-item are considered under the SBSTA and the SBI.<sup>42</sup>
- 40. *Action*: The CMA will be invited to take any action it deems appropriate, including on the basis of the recommendations of the SBSTA and the SBI.

#### (b) Report of the Adaptation Committee

- 41. *Background*: CMA 1 decided that the Adaptation Committee shall serve the Paris Agreement.<sup>43</sup> The Adaptation Committee reports annually to the COP through the subsidiary bodies.<sup>44</sup> Accordingly, matters relating to this agenda sub-item are considered under the SBSTA and the SBI.<sup>45</sup>
- 42. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI. It will also be invited to elect members of the Adaptation Committee.

#### (c) Review of the progress, effectiveness and performance of the Adaptation Committee

- 43. *Background*: COP 27 was to review the progress, effectiveness and performance of the Adaptation Committee, <sup>46</sup> and COP 26 invited CMA 4 to participate in the review as it relates to the Paris Agreement. <sup>47</sup>
- 44. CMA 4 and COP 27 noted that consideration of the review could not be completed at those sessions and would therefore continue at SB 58.48 The review was considered at

SB 58, 59 and 60.<sup>49</sup> SB 61 agreed that SB 62 would continue consideration of the matter,<sup>50</sup> but SB 62 could not complete consideration thereof.<sup>51</sup> Accordingly, matters relating to this agenda sub-item are considered under the SBSTA and the SBI.<sup>52</sup>

45. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI.

# 9. Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts

- 46. *Background*: COP 19 and 20 requested the WIM Executive Committee to report annually to the COP through the subsidiary bodies and to make recommendations, as appropriate.<sup>53</sup> Article 8, paragraph 2, of the Paris Agreement states that the WIM shall be subject to the authority and guidance of the CMA and may be enhanced and strengthened as determined by the CMA.
- 47. The governing body or bodies shall consider the joint annual report of the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change and the WIM Executive Committee, submitted through the subsidiary bodies in accordance with paragraph 19 of annex I to decision 12/CMA.4, endorsed by decision 11/CP.27, and other future decisions of the governing body or bodies, and provide guidance thereon.<sup>54</sup> Accordingly, matters relating to the joint annual report of the Santiago network and the WIM Executive Committee are considered under the SBSTA and the SBI.<sup>55</sup>
- 48. SB 62 recommended a draft decision on the 2024 joint annual report of the Santiago network and the WIM Executive Committee for consideration and adoption by the appropriate body or bodies at the session(s) in November 2025.<sup>56</sup>
- 49. CMA 6 noted that considerations related to WIM governance will continue at CMA 7.57
- 50. CMA 2 recommended that a review of the WIM be held in 2024 and every five years thereafter, with the subsidiary bodies to develop the terms of reference for each review at their sessions immediately before they undertake the review and to undertake future reviews and forward the outputs of the reviews to the governing body or bodies.<sup>58</sup> SB 60 finalized the terms of reference for the 2024 review.<sup>59</sup> SB 61 could not conclude consideration of the 2024 review of the WIM.<sup>60</sup> CMA 6 requested SB 62 to continue consideration thereof.<sup>61</sup> SB 62 agreed that SB 63 will continue consideration of the matter with a view to recommending a draft decision or decisions thereon for consideration and adoption by the appropriate body or

bodies at the session(s) in November 2025.<sup>62</sup> Accordingly, matters relating to the review of the WIM are considered under the SBSTA and the SBI.<sup>63</sup>

51. *Action*: The CMA will be invited to take any action it deems appropriate, including on the basis of the recommendations of the SBSTA and the SBI. It will also be invited to elect members of the WIM Executive Committee and the Advisory Board of the Santiago network.

  - 52. *Background*: COP 21 decided that the SCF shall serve the Paris Agreement in line with its functions and responsibilities established under the COP.<sup>64</sup>
  - 53. CMA 6 requested the SCF to report to CMA 7 on progress in implementing its workplan for 2025.65
  - 54. COP 27 adopted the terms of reference for the second review of the functions of the SCF and requested SBI 59 to complete the work on that review with a view to recommending draft decisions on the matter for consideration and adoption at CMA 5 and COP 28.66 SBI 59 and 61 agreed on SBI 61 and 63 respectively continuing consideration of the matter.67 Accordingly, matters relating to the second review of the SCF are considered under the SBI.68
  - 55. Action: The CMA will be invited to consider the SCF report and the recommendations of the SBI on the review of the functions of the SCF and to take any action it deems appropriate.

It recommended that the CMA provide guidance to the GCF on policies, programme priorities and eligibility criteria related to the Agreement for transmission by the COP. It decided that the guidance to the GCF in relevant decisions of the COP, including those agreed before the adoption of the Agreement, shall apply mutatis mutandis to the Agreement.<sup>69</sup>
- 57. *Action*: The CMA will be invited to provide guidance to the GCF on policies, programme priorities and eligibility criteria related to the Paris Agreement for transmission by the COP.

# (d) Report of the Fund for responding to Loss and Damage and guidance to the Fund for responding to Loss and Damage

- 60. *Background*: CMA 5 and COP 28 decided to designate the FRLD as an entity entrusted with the operation of the Financial Mechanism of the Convention, also serving the Paris Agreement, which will be accountable to and function under the guidance of the CMA and the COP.<sup>71</sup>
- 61. The Governing Instrument of the FRLD states that its Board will receive guidance from the CMA and the COP on its policies, programme priorities and eligibility criteria, take appropriate action in response to the guidance received from the CMA and the COP and submit annual reports to the CMA and the COP for their consideration.<sup>72</sup>
- 62. CMA 6 and COP 29 invited Parties to submit views and recommendations on elements of guidance for the FRLD and requested the SCF to take into consideration those submissions when preparing its draft guidance for the FRLD for consideration at CMA 7 and

COP 30, and the Board of the FRLD to include in its annual report to the CMA and the COP information on the steps it has taken to implement the guidance provided.<sup>73</sup>

- 63. CMA 6 and COP 29 approved the arrangements between the CMA, the COP and the Board of the FRLD, and requested the Board to report on the implementation of the arrangements in its annual reports to the CMA and the COP, starting at CMA 7 and COP 30.74
- 64. *Action*: The CMA will be invited to consider the annual report of the Board of the FRLD and take any action it deems appropriate.

#### (e) Matters relating to the Adaptation Fund

- 65. *Background*: CMA 1 decided that the Adaptation Fund shall serve the Paris Agreement under the guidance of, and be accountable to, the CMA with respect to all matters relating to the Paris Agreement, effective 1 January 2019. The CMP 14 took note of that decision. CMA 6 encouraged the Adaptation Fund Board to complete, as a matter of priority, its work related to implementing its mandates in decisions 13/CMA.1 and 1/CMP.14 and to report thereon in its annual report to CMA 7 and CMP 20.77
- 66. CMA 6 requested the Adaptation Fund to provide updates on its activities and scope of support in relation to assisting developing country Parties in their efforts towards the implementation of the United Arab Emirates Framework for Global Climate Resilience, including towards achieving the targets referred to in paragraphs 9–10 of decision 2/CMA.5.78
- 67. CMA 6 also requested SBI 62 to consider the matter of the arrangements for the Adaptation Fund to exclusively serve the Paris Agreement and to make recommendations on this matter for consideration at CMA 7. 79 SBI 62 agreed that SBI 63 will continue consideration of the matter. 80
- 68. CMA 4 requested SBI 58 to continue consideration of matters relating to the membership of the Adaptation Fund Board, as needed, in view of the Adaptation Fund's transition to exclusively serving the Paris Agreement.<sup>81</sup> SBI 62 agreed that SBI 63 will continue consideration of these matters.<sup>82</sup>
- 69. *Action*: The CMA will be invited to take any action it deems appropriate, including on the basis of the recommendations of the SBI.

- (f) <u>Compilation and synthesis of, and summary report on the in-session workshop on, biennial communications of information related to Article 9, paragraph 5, of the Paris Agreement</u>
  - 70. Background: CMA 5 requested developed country Parties to submit their biennial communications by 31 December 2024 and encouraged other Parties providing resources to submit biennial communications on a voluntary basis. It also requested the secretariat to prepare a compilation and synthesis of the biennial communications submitted in 2024 in accordance with paragraph 7 of decision 12/CMA.1, organize in 2025 an in-session workshop on information to be provided by Parties in accordance with Article 9, paragraph 5, of the Paris Agreement and prepare a summary report thereon for consideration at CMA 7.83
  - 71. The workshop took place during SB 62.84
  - 72. The CMA decided to consider, and invited the COP to consider, the compilations and syntheses of the information included in the biennial communications and the summary reports on the in-session workshops starting in 2021.85
  - 73. CMA 5 welcomed the deliberations at the second high-level ministerial dialogue on climate finance in accordance with paragraph 10 of decision 12/CMA.1 and looked forward to the summary thereof to be prepared by the President of CMA 5 for consideration at CMA 7.86
  - 74. CMA 5 decided that CMA 7 is to consider updating the types of information specified in the annex to decision <u>12/CMA.1</u> on the basis of the experience of and lessons learned by Parties in preparing their biennial communications of indicative quantitative and qualitative information.<sup>87</sup>
  - 75. Action: The CMA will be invited to consider the compilation and synthesis of the third biennial communications in accordance with Article 9, paragraph 5, of the Paris Agreement, the summary report on the 2025 in-session workshop, the summary note on the second biennial high-level ministerial dialogue on climate finance under the CMA, and the types of information contained in the annex to decision 12/CMA.1.

Background: CMA 4 decided to launch the Sharm el-Sheikh dialogue between Parties, relevant organizations and stakeholders to exchange views on and enhance understanding of the scope of Article 2, paragraph 1(c), of the Paris Agreement and its complementarity with Article 9 of the Paris Agreement.<sup>88</sup>

- 77. CMA 5 decided to continue and strengthen the Sharm el-Sheikh dialogue between Parties, relevant organizations and stakeholders to exchange views on and enhance understanding of the scope of Article 2, paragraph 1(c), of the Paris Agreement and its complementarity with Article 9 of the Paris Agreement referred to in paragraph 68 of decision 1/CMA.4, including with regard to the operationalization and implementation of Article 2, paragraph 1(c), in 2024–2025.<sup>89</sup>
- 78. CMA 5 also decided that this dialogue is to be facilitated by two co-chairs; requested the secretariat, under the guidance of the co-chairs, to organize at least two workshops per year with a view to engaging a broad range of relevant stakeholders; and also requested the co-chairs to prepare a report on the deliberations under the dialogue in 2024 and 2025 for consideration at CMA 6 and 7 respectively. CMA 5 further requested the co-chairs to prepare, as part of the 2025 report, a synthesis of all work undertaken under the Sharm el-Sheikh dialogue for consideration at CMA 7 with a view to CMA 7 deciding on a way forward with regard to its deliberations on this matter.<sup>90</sup>
- 79. CMA 6 noted with appreciation the annual report by the co-chairs on the Sharm el-Sheikh dialogue and encouraged the co-chairs to continue enhancing their efforts to organize and conduct the workshops held under the dialogue in 2025. The first workshop in 2025 took place from 17 to 18 June in Bonn. The second workshop will take place from 6 to 7 September in Rome.
- 80. *Action*: The CMA will be invited to consider the report and take any action it deems appropriate.

CMA 6 requested SBI 62 to continue consideration of this matter with a view to recommending a draft decision for consideration and adoption at CMA 7.93 SBI 62 agreed that SBI 63 will continue consideration of this matter with a view to recommending a draft decision for consideration and adoption at CMA 7.94 Accordingly, matters relating to the modalities for the dialogue are considered under the SBI.95
  - 83. *Action*: The CMA will be invited to consider this matter and take any action it deems appropriate on the basis of the recommendations of the SBI.

- (a) <u>Joint annual report of the Technology Executive Committee and the Climate Technology</u>
  <u>Centre and Network</u>
  - 84. *Background*: CMA 1 adopted the technology framework under Article 10, paragraph 4, of the Paris Agreement and took note of the recommendation of the Technology Executive Committee and the Climate Technology Centre and Network to prepare and submit their joint annual report to both the CMA and the COP, <sup>96</sup> through the subsidiary bodies, on their activities to support the implementation of the Paris Agreement. <sup>97</sup> Matters relating to this agenda sub-item are considered under the SBSTA and the SBI. <sup>98</sup>
  - 85. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI.

- 86. *Background*: COP 29 decided that COP 30 is to conduct a review of the functions and decide whether to extend the term of the Climate Technology Centre. 99 CMA 6 decided that CMA 7 is to participate in conducting the review and deciding whether to extend the term of the Climate Technology Centre. CMA 6 requested SBI 62 to initiate the review with a view to recommending a draft decision on this matter for consideration and adoption at CMA 7.100
- 87. SBI 62 agreed that SBI 63 will continue consideration of this matter<sup>101</sup> and consider criteria relating to selecting a host for the Climate Technology Centre with a view to recommending draft decisions for consideration and adoption at COP 30 and CMA 7.<sup>102</sup> Accordingly, matters relating to this agenda sub-item are considered under the SBI.<sup>103</sup>
- 88. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBI.

- 89. *Background*: CMA 5 decided to establish a technology implementation programme and invited SBI 61 to take into account the technology implementation programme in its consideration of the Poznan strategic programme on technology transfer with a view to recommending a draft decision thereon for consideration and adoption at CMA 6.<sup>104</sup>
- 90. CMA 6 decided to launch a process for elaborating the technology implementation programme and requested SBI 62 to consider this matter on the basis of the results of Parties' deliberations thereon at CMA 6 105 with a view to recommending a draft decision for consideration and adoption at CMA 7 with a view to informing and further elaborating the technology implementation programme. 106

- 91. SBI 62 could not conclude consideration of this matter.<sup>107</sup> In accordance with rules 10(c) and 16 of the draft rules of procedure being applied, this item has been included in the provisional agenda for this session. Matters relating to this agenda sub-item are considered under the SBI.<sup>108</sup>
- 92. *Action*: The CMA will be invited to consider this matter and take any action it deems appropriate on the basis of the recommendations of the SBI.

### 12. Matters relating to capacity-building

- 93. *Background*: The PCCB prepares annual technical progress reports on its work for submission to the COP through the SBI.<sup>109</sup> CMA 2 decided that the PCCB shall serve the Paris Agreement in accordance with its mandate and terms of reference and confirmed that the PCCB shall report to both the CMA and the COP through its annual technical progress report.<sup>110</sup>
- 94. CMA 6 decided to extend the PCCB for five years and requested the PCCB, at its 9<sup>th</sup> meeting, to develop a workplan for the period of its extension on the basis of the priority areas and activities set out in the annex for consideration at CMA 7.<sup>111</sup> CMA 6 also requested the secretariat, under the guidance of the PCCB, to organize the 7<sup>th</sup> Capacity-building Hub, to be held at the United Nations Climate Change Conference in November 2025.<sup>112</sup> Matters relating to this agenda item are considered under the SBI.<sup>113</sup>
- 95. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBI.

#### 13. Matters relating to the least developed countries

- 96. *Background*: The COP decided to extend the mandate of the LEG under its current terms of reference; that the next review of the mandate of the LEG will take place at COP 36; to take stock of the work of the LEG in order to review its progress and terms of reference at COP 31, the midway point before the review, as a way to reflect on the evolving needs of the least developed countries; and to outline the steps for that stocktake at COP 29.<sup>114</sup>
- 97. SBI 61 initiated consideration of the steps for the stocktake of the work of the Group and agreed that SBI 63 will continue consideration thereof with a view to preparing for the review by the COP and the CMA and recommending draft decisions for consideration and adoption at COP 30 and CMA 7.<sup>115</sup> Accordingly, matters relating to this agenda item are considered under the SBI.<sup>116</sup>
- 98. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBI.

# 14. Report of the forum on the impact of the implementation of response measures

- 99. *Background*: CMA 1, COP 24 and CMP 14 acknowledged that a single forum on the impact of the implementation of response measures covers the work of the CMA, the COP and the CMP on all matters relating to the impact of the implementation of response measures and affirmed that the forum shall report to the CMA, the COP and the CMP.<sup>117</sup>
- 100. CMA 1 decided that the forum shall provide recommendations for consideration by the subsidiary bodies with a view to them recommending actions for consideration and adoption by the CMA, the COP and the CMP. 118
- 101. CMA 6, COP 29 and CMP 19 adopted the workplan of the forum and its Katowice Committee of Experts on the Impacts of the Implementation of Response Measures for 2026–2030.<sup>119</sup>
- 102. SB 62 convened a meeting of the forum and agreed that SB 63 will continue work in the forum with a view to recommending a draft decision for consideration and adoption at CMA 7, COP 30 and CMP 20.<sup>120</sup> Accordingly, matters relating to this agenda item are considered under the SBSTA and the SBI.<sup>121</sup>
- 103. *Action*: The CMA will be invited to take any action it deems appropriate on the basis of the recommendations of the SBSTA and the SBI.

### 15. Matters relating to Article 6 of the Paris Agreement

(a) <u>Implementation of the guidance on cooperative approaches referred to in Article 6, paragraph 2, of the Paris Agreement</u>

104. Background: CMA 3 adopted the guidance on cooperative approaches referred to in Article 6, paragraph 2, of the Paris Agreement; requested the secretariat to prepare annually a compilation and synthesis of the results of the Article 6 technical expert review, including identification of recurring themes and lessons learned, for consideration by the CMA, including in the context of its review of the guidance; and also requested the secretariat to provide an annual report to the CMA on the activities relating to recording and tracking cooperative approaches, including information on recorded internationally transferred mitigation outcomes, corresponding adjustments and emission balances. 122

105. Action: The CMA will be invited to take any action it deems appropriate.

- (b) Report of the Supervisory Body and guidance for the mechanism established by Article 6, paragraph 4, of the Paris Agreement
  - 106. *Background*: CMA 3 designated the Supervisory Body for the mechanism established by Article 6, paragraph 4, of the Paris Agreement to supervise the mechanism<sup>123</sup> and CMA 4 adopted its rules of procedure.<sup>124</sup> In accordance with the rules, modalities and procedures for the mechanism, the Supervisory Body is to report annually to the CMA.<sup>125</sup>
  - 107. *Action*: The CMA will be invited to consider the annual report and the recommendations of the Supervisory Body with a view to adopting the recommendations and to provide guidance to the Supervisory Body, as appropriate. It will also be invited to elect members and alternate members of the Supervisory Body.

- (c) Work programme under the framework for non-market approaches referred to in Article 6, paragraph 8, of the Paris Agreement in decision 4/CMA.3
  - 108. *Background*: CMA 3 adopted the work programme under the framework for non-market approaches <sup>126</sup> and established the GCNMA to implement the framework and the work programme, to be convened by the SBSTA Chair in conjunction with sessions of the SBSTA. <sup>127</sup> The progress and outcomes of the work programme will be reported at each session of the CMA, as appropriate, on the basis of information resulting from implementation of the work programme activities. <sup>128</sup>
  - 109. CMA 6 welcomed the expedited and simple assessment of the first phase of implementing the work programme activities undertaken at GCNMA 6 and noted that, in the first phase, Parties identified and framed all relevant elements of the work programme activities and that the secretariat developed the NMA Platform <sup>129</sup> and an associated user manual. <sup>130</sup>
  - 110. CMA 6 noted with appreciation the synthesis report by the secretariat on topics for spin-off groups and existing NMAs in the initial focus areas of the work programme activities and noted that Parties may consider those as potential themes for spin-off groups during GCNMA 7 and 8. It encouraged interested Parties to showcase examples of NMAs by recording them on the NMA Platform and noted that those NMAs may be used to identify potential themes for spin-off groups during GCNMA 7 and 8. [13]
  - 111. CMA 6 invited Parties and observers to submit views on barriers to using the NMA Platform and potential solutions, their engagement with the Platform and the challenges encountered in unlocking its full potential, and how NMAs can support a Party's implementation of its NDC.<sup>132</sup> Accordingly, matters relating to this agenda sub-item are considered under the SBSTA.<sup>133</sup>
