### **High-Level Segment**

#### **United Nations Climate Change Conference Belém, Brazil**

The High-Level Segment (HLS) of COP 30/CMP 20/CMA 7 will be held on **Monday, 17 and Tuesday, 18 November 2025** and will hear national statements from those Parties and representatives of groups who have registered and confirmed their wish to deliver a national or group statement.

Upon conclusion of national statements, the High-Level Segment will hear statements from intergovernmental organizations and groups of non-governmental organizations admitted by the Conference of the Parties.

Parties will have only one opportunity to deliver a national statement at the joint plenary meetings of the COP, CMP and the CMA to be held during the High-Level Segment. National statements may be delivered by the Head of State or Government, a minister or the head of delegation or other senior officials.

There will be one list of speakers for Parties to the Convention, the Kyoto Protocol and the Paris Agreement. Parties will have only one opportunity to deliver a national statement at the joint plenary meetings of the COP, the CMP and the CMA, to be held during the High-Level Segment.

The list below represents speakers for Parties who are confirmed to deliver a national statement or statement on behalf of a UNFCCC negotiating group at the High-Level Segment of COP 30/CMP 20/CMA 7.



## **Modalities for the High-Level Segment and delivery of National Statements**

### **Access and Seating Arrangements for the Opening of the High-Level Segment**

To ensure the safety and security of all participants, and an orderly and smooth access to the Plenary Amazonas, **ticketing arrangements will be in place for the opening of the High-Level Segment.**

- Four tickets per Party – two seats at the table and two behind - will be made available behind the nameplate of each Party
- Two tickets per United Nations Systems, specialized agencies and other relevant organizations - one seat at the table and one behind - will be made available behind the nameplate of each organization.
- Two tickets per intergovernmental organization - one seat at the table and one behind - will be made available behind the nameplate of each organization.
- A select number of tickets will be provided to the NGO constituencies through their respective constituency focal point.
- Tickets for the opening of the High-Level Segment can be collected from the Distribution counter located at the **Service Hub area D** at the Conference venue between 10:00 – 18:00 on Friday, 14 and Saturday, 15 November 2025. It will also be possible to collect tickets on Monday, 17 November from 08:00 – 10:00.
- **No tickets will be needed for Tuesday, 18 November.**
- Plenary Tocantins will be available for those delegates who will not have a seat in Plenary Amazonas to view the live webcast of the formal opening of the High-Level Segment.
- No ticket is needed to view the live webcast in Plenary Tocantins.

**All speakers should ensure that they are in the plenary room at least five speakers ahead for the delivery of their national statement.** Speakers will be escorted by an usher during the presentation of the previous speaker from the seat of their delegation to a reserved chair close to the podium. **Speaking slots for those who are not in the plenary at the time for delivery of their statement will be rescheduled to speak at the end of all statements of the same category.**

Given the number of Parties and other observer speakers and the limited amount of time available for statements, it will be necessary to limit the duration of each statement. Representatives are reminded that statements made during the High-Level Segment should not exceed the **three-minute limit for Parties and 2 minutes for observer organizations**. To be fair to all speakers, time limits will be strictly enforced. An electronic/mechanical device will be used to mark the 3-minutes allotted to Parties and the 2-minutes allotted to observer organizations. This will allow all speakers to deliver their statements. Speakers are strongly encouraged to ensure their statements do not exceed allotted times. Statements on behalf of negotiating groups should not exceed **five minutes**.



National statements will be delivered reflecting protocol order in accordance with the United Nations. The secretariat is not able to accommodate individual requests for changes in a Party's speaking slot. Parties wishing to make a change should arrange to exchange slots with another Party in the same rank, and both Parties jointly notify the secretariat of the agreement that has been reached.

Full texts of official statements will be posted on the UNFCCC website. To have statements posted on the UNFCCC website, Parties speaking at the High-Level Segment on 17 and 18 November are requested to send an electronic file containing the statement in advance to [cophls@unfccc.int](mailto:cophls@unfccc.int).

Should Parties not wish to speak but prefer only to have their statements uploaded to the UNFCCC website on 19 November, following the delivery of national statements. The secretariat will arrange to have this done and enter the statement in the records of the Conference. Parties interested in taking up this option should communicate their interest in writing to the External Relations office by sending their statements to the External Relations office at [cophls@unfccc.int](mailto:cophls@unfccc.int) no later than Tuesday, 18 November or to the External Relations team, who will also be located at the front of the plenary during the High-Level Segment.

### **Interpretation**

The United Nations Department for General Assembly and Conference Management (DGACM) is responsible for providing simultaneous interpretation in the six official languages of the United Nations (Arabic, Chinese, English, French, Russian and Spanish) for the High-Level Segment. The UNFCCC secretariat collaborates with the DGACM team assigned to COP 30 to schedule these interpretation services.

It is possible for a speech to be given in a language other than the six official United Nations languages. Parties wishing to deliver their statements in their national language, other than the six UN languages, are requested to inform the secretariat in advance to [cophls@unfccc.int](mailto:cophls@unfccc.int). Parties can provide their own interpreter for the duration of their statement only, or a written official English translation and a prompter from the speaker's delegation to support the English booth to check against delivery. Requests for interpretation in another language other than the six official languages of the United Nations shall be made in writing to ([cophls@unfccc.int](mailto:cophls@unfccc.int)).

To ensure the quality of interpretation of national statements, an electronic copy of the statement should be provided to the Conference Officer at [Conference-Officer@unfccc.int](mailto:Conference-Officer@unfccc.int) and copied to [cophls@unfccc.int](mailto:cophls@unfccc.int) at least 60 minutes prior to delivery of the statement.

Owing to technical difficulties, the secretariat would like to inform Parties that the option for use of a teleprompter will not be available during the High-Level Segment.
