Dear colleagues,

We are pleased to provide further information on the organization of the second workshop in 2025 under the Sharm el-Sheikh dialogue.

The second workshop in 2025 will take place in **Rome, Italy, on 6 -7 September 2025, in a hybrid format**. The theme of the second workshop, as announced in the [message](#) dated 30 April 2025, will be “Article 2, paragraph 1(c) of the Paris Agreement and its complementarity with Article 9, after ten years of the Paris Agreement and three years of the Sharm el-Sheikh Dialogue”, covering the following:

- Stocktake of actions at the domestic and global level to implement Article 2, paragraph 1(c) of the Paris Agreement and its complementarity with Article 9;
- Reflections on the Sharm el-Sheikh Dialogue 2023-2025 and looking forward to CMA 7.

The workshop will be co-hosted by the Government of Italy and the Food and Agriculture Organization of the United Nations.

The workshop will take place in conjunction with the 2025 Forum of the Standing Committee on Finance (SCF) and the 38th meeting of the SCF, which will take place during the week of **8 to 11 September in Rome, Italy**.

Details regarding in-person and virtual participation will be communicated directly to registered participants. In view of the need to confirm the arrangements for the second workshop as early as possible, nominations received after the deadline may not be processed.

We would like to reiterate our intention to conduct the dialogue in an open, inclusive, and transparent manner, ensuring participatory representativeness.
